- 2. Minutes of the previous meeting: The minutes of the Annual Parish Meeting and the last Parish Council meeting held on 16 May were approved and signed as a true record.
- 3. Matters Arising:
- 3.1 25 Year Environmental Plan: Keith Gittens advised that the Wildflower meadow to the rear of the recreation area can now be cut. Two complaints have been received concerning grass cutting in the village cemetery and the PC agreed that the grass cutting plan for the cemetery needed review before next spring. Yorkshire and Humber Climate Commission are undertaking a consultation and YLCA are gauging interest in Carbon Literacy training but it was agreed to ask County Councillor Baker for information from NYC in the first instance. - 3.2 Updating the 2006 Parish Plan: Monthly meetings are taking place and materials for the launch event are being prepared. More participants are needed and it is hoped that the launch event will generate interest.
- 3.3 Lime Tree on the Village Green: Keith Gittens has sent samples from the tree to Forest Research for testing and the results are awaited.
- 3.4 Communications Policy: This is now ready for circulation prior to being adopted by the PC. Action: CN/SA
- 3.5 King Charles III Coronation mugs: The mugs have been received and distributed. There are still a few available if any under 18s in the parish would like to receive one. Action: CF
